Subject: **Distribution of space for delivery of CMR by rice mills to FCI as per "The Punjab Custom Milling Policy for Paddy (Kharif 2019-20)"...reg.**

Please refer to the subject cited above.

2. A lot of demand and complaints regarding the distribution of space for delivery of CMR by rice mills to FCI as per "The Punjab Custom Milling Policy for Paddy (Kharif 2019-20)" are being received in this office which were referred to FCI for redressal of the same. In this regard, FCI has intimated that the distribution of space for delivery of CMR amongst the mills is dependent on various factors which vary from centre to centre and district to district and one formula may not be applicable for for all the centres/districts of the State and therefore, it has been suggested by FCI that a standing committee may be constituted comprising of all the district heads of the agencies and DM, FCI at district level to take action for allotment of storage space/stacks to the mills as per day to day scenario prevailing at the storage centres to avoid any dispute among the millers.

3. In this regard, it is clarified that FCI, along with all SPAs, is bound to adhere to the ibid policy which prescribes a specific delivery schedule. Thus, it is directed that a standing committee be constituted in each district where the District Managers of all the SPAs along with FCI would be it's members and DFSC would be it's Chairman to address the constant flow of such complaints by the millers regarding equitable distribution of space. The committee would apportion space as per local conditions, millings percentages, paddy stored (including RO Paddy) and adherence to provisions of the ibid policy.
