## 2. Eligibility Criteria:

- (i) The Chairman/Member shall be appointed from amongst persons-
- (a) who are or have been members of the All India Services or any other civil services of the Union or State or holding a civil post under the Union or State having knowledge and experience in matters relating to food security, policy making and administration in the field of agriculture, civil supplies, nutrition, health or in any allied field: or
- (b) of eminence in public life with wide knowledge and experience in agriculture, law, human rights, social service, management, nutrition, health and policy or public administration: or
- (c) who have a proven record of work relation to the improvement of the food and nutrition of the poor.

### Age limit and tenure:

The Chairman / Member of the State Commission shall hold office for a term not exceeding five years from the date on which he enters upon the office, and shall be eligible for re-appointment. Provided that no person shall hold as Chairman/Member after he has attained the age of 65 years. The Chairman/Member shall not concomitantly hold any office.

4. The applicants are advised to go through the provisions of National Food Security Act, 2013 and satisfy themselves about their eligibility and other conditions for being appointed as Chairman or Member.
