Subject: Guidelines regarding payment of service charges to the service providers/Contractors for hiring of staff on contract through a service provider (Outsourced staff).

Sir/Madam,

I am directed to invite a reference to Punjab Government's letter No. 7/74/2018-1FP1/734-739 dated 27-08-2018 and letter no. 7/74/2018-1FP1/858-863 dated 11-10-2018 on the subject cited above and to state that at the time of hiring staff on contract of any category through service provider / contractor, maximum services charges paid to the service provider/contractor shall in no case be more than $2\frac{1}{2}\%$ (Two and half percent) of the amount of contract.
