Managing Director, Punjab State Grain Procurement Corporation (hereinafter referred to as PUNGRAIN) Chandigarh invites division wise e-tenders for disposal of empty bottles/ containers of chemicals/ fumigants used for preservation of foodgrains. Tenderers who fulfill the prescribed eligibility criteria/ requirements may submit their offer in the prescribed mode of e-tender submission.

1. Tender Document Contents:

The terms and conditions governing the sale are given at Page no. 2 to 11, Technical Bid at page no. 12, Financial Bid format at Page no. 13, Division wise/District wise/Centre wise detail of Quantity of empty bottles/containers of the Chemicals/Fumigants at Annexure 'A', Particulars to be filled and uploaded at Annexure 'B', Affidavit regarding abiding by of Hazardous Waste Management Rules 2016 at Annexure 'C', Affidavit for non-blacklisting of the firm at Annexure 'D' attached herewith. Each tenderer will have to quote rate(s) as per clause '8' of terms & conditions of the tender.

1.1 Availability of e-Tender Documents:

E-tender documents may be downloaded in electronic form from e-Procurement website of Punjab Public Procurement Portal: <https://eproc.punjab.gov.in>. The detailed E-tender document can also be viewed at official website of PUNGRAIN i.e. <http://foodsuppb.gov.in/>.

2. Information to e-Tenderers/ Instructions for E-Bid submission

government working days or reach through e-mail at **eproc@punjab.gov.in**, support-**eproc@nic.in**. PUNGRAIN may at any time prior to the opening of the e-tender and for any reason, whether at its own initiative or in response to any on-line query sought by a e-tenderer, modify the e-tender document by way of an addendum/ corrigendum to the original e-tender and such modification shall be binding on all e-tenderers. Such addendum/ corrigendum, if any would be uploaded on **<https://eproc.punjab.gov.in>**. In order to afford the prospective e-tenderer to take into account the modification or for any other reasons, PUNGRAIN may, at its discretion extend the due date for submitting the e-tender.

3. E-Tender Procedures

A. Issue of e-Tenders

The e-tender forms (Non Transferable) containing terms, conditions, Earnest Money Deposits and stipulations shall be available on website **<https://eproc.punjab.gov.in>** w.e.f. 16-05-2023 onwards. Those who download the e-tender document and submit the same by uploading on the website **<https://eproc.punjab.gov.in>** shall have to pay Rs. 3,600/- (non-refundable) online towards cost of e-tender form at time of submission of e-tenders without which the e-tender offer shall not be considered as valid. For participation, the tenderer/s shall have to get themselves registered with **<https://eproc.punjab.gov.in>** and get the User ID and Password to submit their bid offers online after logging in to their accounts accordingly. For participation in the e-tendering process, Class III Digital Signature (DSC) is mandatory. Any processing fee required while uploading the tender on eproc portal is to be borne by the tenderer.

B. Submission of DNIT:

The last date and time of submission of the e- tenders (both the Technical and Financial Parts) shall be 31-05-2023 till 05:00 PM. The tenderer/s are at liberty to be present at the time of opening of the e-tender/s and PUNGRAIN is not liable for calling any of the tenderer/s in writing. It is at the discretion of the Managing Director or his authorized officer-in-charge to reject any or all the e-tender/s without assigning any reason/s thereof. E-tenders accompanied by prescribed Earnest Money Deposits and cost of e-tender form shall be submitted by uploading on the website <https://eproc.punjab.gov.in> upto 05:00 PM IST on 31-05-2023. The e-tenders shall be opened at 09:00 AM IST on 01-06-2023 at Anaaj Bhawan, Sector-39-C, Chandigarh in presence of tenderers or their representatives with authority letter, who may wish to be present. E-tenders not accompanied by Earnest Money Deposits and cost of e-tender forms shall be summarily rejected.

- C. If there are any clarifications, the same may be obtained online through the e-tender site, or through the contact details. Tenderer should take into account the corrigendum, if any, published before submitting the bids online.
- D. It is construed that the tenderer has read, understood and accepted all the terms and conditions before submitting their offer. Tenderer should go through the e-tender schedules carefully and upload the documents as asked; otherwise, the bid shall be rejected.
- E. Withdrawal of bids is not allowed, once bids are submitted. In case of withdrawal, EMD shall be forfeited.

4. Earnest money deposit:

- i. Each e-tender (Technical Part) must be accompanied with Earnest Money Deposit (EMD) prescribed for each division, as follows which is to be paid online through <https://eproc.punjab.gov.in> portal.

Note: The actual quantity/ weight of stock may increase or decrease but the e-tenderer shall have to lift the entire stock available at particular center at his own cost and without any objection. PUNGRAIN does not guarantee any specific volume of business.

- ii. No interest shall be paid by PUNGRAIN on the amount of EMD.
- iii. Tenderers are at a liberty to submit e-tenders for one or more division/s as detailed at **Annexure- "A"**. In that case, Bidders applying for more than one division shall pay EMD for all such divisions.
- iv. No tenderer is exempted from furnishing the cost of e-tender form and Earnest Money Deposit (EMD) under any circumstances.
- v. EMD of bidders declared successful will be converted into security amount and for unsuccessful bidders EMD will be refunded online from portal.

- vi. In case of acceptance of rate, EMD will be adjusted into performance security and excess EMD, if any, will be refunded as per request of the party.

5. Security Amount

- i. The successful bidder(s) will have to deposit 5% of total value of tendered quantity (inclusive of EMD) with PUNGRAIN within 04 working days from the work order. In case, the security money is not deposited, earnest money will be forfeited.
- ii. Security amount will be forfeited, in case of any default or any violation of the terms & conditions or the non-acceptance of the work order on the part of the bidder. PUNGRAIN will not be liable to pay any interest on the security.
- iii. The security deposit shall be released by the Head Office of PUNGRAIN on production of no objection certificates by the bidder(s) from the districts/division(s) after successful completion of lifting of empty containers of the chemicals/ fumigants.

6. Signing/ Submission of e-tender

Person(s) signing the e-tender shall state in what capacity he/she or they are signing the e-tender e.g. as a Sole Proprietor of a firm or as Secretary/ Manager/Director etc. of a body corporate. The original or an attested copy of the partnership deed shall be furnished along with the e-tender. In case of a limited company, (i) name of Directors shall be mentioned, and (ii) it shall be certified that the person signing the e-tender is empowered to do so on behalf of the company.

7. Technical Bid- Opening and Evaluation

i. Opening of e-Tenders

PUNGRAIN shall open the Technical Bid of all e-tenderers received through e-procurement portal on the specified date and time. Conditional offers shall be rejected outrightly. The e-tender containing erase and overwriting shall not be accepted unless these are duly signed by the person signing the e-tender form. In the event of the specified date of e-tender opening being declared a holiday for PUNGRAIN, the e-tenders shall be opened on the next working day but there shall be no change in the time for opening as indicated in the e-tender.

ii. Evaluation

The tenderer shall fill the relevant details in the technical bid format at page no. 12 and duly sign the technical bid and each page of the terms and conditions of the tender in full signature and upload the same alongwith the mandatory documents required with the technical bid. It is clarified that

facsimile signatures will not be accepted. The tenderers shall furnish the mandatory documents with the technical bid. The tenderer must upload all the documents mentioned in the Technical bid proforma to qualify in the technical bid. The technical bid will be opened and evaluated first the financial bid of only those tenderers shall be opened who are technically eligible. The date and time for the opening of financial bid will be notified online to the technically eligible bidders. Bids which are not submitted the prescribed form and/ or without deposit of requisite tender fee and/ or earnest money and/ or without requisite documents or any other deviation from the terms & conditions of the tender notice shall be rejected out-rightly.

8. Financial Bid - Submission and evaluation

- i.** After the technical evaluation is completed, PUNGRAIN shall open the Price Bid of only technically qualified e-tenderer on subsequent date & time which shall be intimated to the e-tenderer(s) online.
- ii.** The offers/ rates are to be submitted online on e-tendering portal only. No rates should be quoted in technical bid. The bid quoting rate in technical bid will not be considered and shall be rejected out rightly.
- iii.** Tenderer is to quote rate per bottle for empty bottles of Aluminum Phosphide and per kg for empty Malathion Tins and DDVP Plastic Bottle (exclusive of GST). The per bottle/ per kg rate should be equal or more than the minimum reserved price as shown in the table below. The rates offered/ quoted, less than minimum reserved price, will not be considered and shall be rejected out-rightly.

- iv.** GST or any other taxes/ levies as applicable shall be extra and borne by the bidder/ successful tenderer.

9. Bid Validity

The offer shall remain valid for **30 (thirty) days** from the date of opening of the e-tender documents. Bids with lesser validity shall be rejected. The Managing Director, PUNGRAIN may at his sole discretion extend the date of submission of e-tender by any time and such extension shall be binding on the tenderers. The Managing Director may relax any of the terms or conditions of this e-tender.

10. Disqualification of Tenderer

i. Tenderers who fall under any of the categories stipulated below are ineligible to apply:

- a. Tenderers who have been blacklisted or otherwise debarred by PUNGRAIN or any Department of Central or State Government or any other Public Sector Undertaking will be ineligible during the period of such blacklisting or for a period of five years, whichever is earlier. It is clarified that anybody either in individual capacity or as a director of a firm / company or a partner of partnership firm/company upon blacklisting anywhere by any procurement agency shall attract its contagious effect. Meaning thereby where ever the same blacklisted entity/person is connected either as an individual or director or partner or member of governing body, all such firms/ companies/ partnership firms / trusts /societies / with any other names as a juristic entity shall have the same effect of them being treated as BLACKLISTED.
- b. Any Tenderer whose Contract with the PUNGRAIN or any Department/corporation/ Agency of Central or State Government or any other Public Sector Undertaking has been terminated before the expiry of the Contract period at any point of time during last five years, will be ineligible.
- c. Tenderer whose Earnest Money Deposit and/or Security Deposit has been forfeited by PUNGRAIN or any Department of Central or State Government or any other Public Sector Undertaking, during the last five years, will be ineligible.
- d. Tenderer who is blacklisted by the GST authorities.
- e. If the Proprietor / any of the Partners of the Tenderer firm/any of the Director of the Tenderer company have been, at any time, convicted by a court for an offence and sentenced to imprisonment for a period of three years or more, such Tenderer will be ineligible.
- f. While considering ineligibility arising out of any of the above clauses, incurring of any such disqualification in any capacity whatsoever (even as a Proprietor, Partner in another firm, or as Director of a Company etc.) will render the Tenderer disqualified.

ii. The onus of ensuring the eligibility condition would be on the Tenderer and any party found subsequently ineligible would be summarily rejected and the EMD and Security Deposit as the case may be in such case is liable to be forfeited.

11. Award of Contract

- a) Bidder quoting the highest rate for a particular division will be declared as H1 for that particular division by issue of Acceptance letter by e-mail which shall be binding on the E-tenderer.
- b) Work order will be issued to H1 bidder(s) for a particular division.

- c) If H1 bidder resiles from its offer, then work order can be issued to H2 bidder for that particular division. In that case, earnest money of H1 bidder shall be liable to be forfeited by PUNGRAIN.
 - d) If more than one bidder is found as H1 for a particular division, then quantity of Empty bottles/containers of the chemicals/ fumigants for that particular division, will be divided equally amongst all H1 bidders.
 - e) The tenderer(s) shall not sub-let, transfer or assign the award of any part thereof without the prior written approval of PUNGRAIN.
- PUNGRAIN reserves the right to accept or reject the whole or any part of the e-tender or portion of the quantity offered without assigning any reason whatsoever and does not bind itself to accept the highest e-tender or any e-tender.

12. Corrupt Practices

- i.** Any bribe, commission, or advantage offered or promised by or on behalf of the Tenderer to any Officer or Official of Pungrain shall (in addition to any criminal liability which the Tenderer may incur) debar his tender from being considered. Canvassing on the part of, or on behalf of, the Tenderer will also make his tender liable to rejection.
- ii.** Tenderers shall not indulge in any anti-competitive practices/agreements implied or express while participating in the Tender.
- iii.** In case of any clear indication of cartelization or express/implied anti-competitive agreements between the tenderers at the time of finalization of Tender or thereafter, which at any time i.e. before or after award of the Contract comes to the notice of the Pungrain, the Tendering Authority may reject the relevant Tenders, forfeit their EMD/Security Deposit as the case may be, recover the losses as assessed by the authority arising out of such anti-competitive practices of the Tenderer(s) and also recommend the case to Competition Commission of India or any other department having appropriate jurisdiction or Authority, for initiating necessary action including, but not restricted to, cancellation of license. PUNGRAIN reserves the right to initiate appropriate legal action against the Tenderers if the indication of cartelization comes to notice even after award of contract/expiry of contract.
- iv.** In case of breach of any terms and conditions of the Tender Documents by the Tenderer, PUNGRAIN reserves the right to summarily terminate the contract including forfeiture of EMD/ Security Deposit as the case may be

without prejudice to any other rights or remedies PUNGRAIN may have under the Contract and Law.

- v. The tenderer shall not offer or give or agree to give any person in the employment of the purchaser or working under the orders of PUNGRAIN/ State agency any gift or consideration of any kind as an inducement or reward for doing or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the contract with PUNGRAIN for showing or forbearing to show favor or disfavor to any person in relation to the contract with PUNGRAIN. Any breach of the aforesaid condition by the tenderer or any one employed by him or acting on his behalf whether with or without the knowledge of the tenderer or the commission of any offence by the tenderer or by any one employed by him or acting on his behalf shall entitle PUNGRAIN to Terminate the contract and to recover from the tenderer the amount of any loss arising from such Termination.

13. Lifting of empty bottles/ containers

- i. Lifting would be undertaken within six weeks from the allotment of work order during working hours on all working days on presentation of copy of release order.
- ii. The tenderer shall also make his own arrangement for transportation of the stock without expecting any type of assistance or help from PUNGRAIN.
- iii. The prospective tenderer would be responsible for arranging all or any sort of permission(s) required for movement/ transportation or consumption of the empty containers sold from the appropriate authority, if required.
- iv. In case the original tenderer desires to lift the empty bottles/containers purchased under this e-tender, through a representative, he/ she must authorize the representative by a letter of authority which shall be presented to the concerned District Manager for permission to get delivery of the empty bottles/containers. Such officer may be at his entire discretion decline to act on such an authority and it shall be the sole responsibility of the e-tenderer to satisfy such officer that the authority is genuine. Delivery by proxy shall be at e-tenderer's sole responsibility and no claim shall lie against PUNGRAIN on any account whatsoever if delivery is affected to a wrong person.
- v. The goods sold will have to be lifted from the storage point within the stipulated lifting period from the date of work order i.e. six weeks. MD, PUNGRAIN reserves the right to extend the lifting period, for a period deemed

fit, with or without late lifting charges, in case of delay due to reasons/ circumstances beyond the control of bidder on a case-to-case basis depending upon the exigencies of the situations.

vi. Liquidated Damages:

For delay in lifting of material beyond stipulated period/extended period whichever the case may be, penalty @ 1% for the first 7 days or part of it on the value of goods un-lifted and 2% for 8th to 14th day shall be levied which shall be recovered/ deducted from the EMD and Security. PUNGRAIN reserves the right to cancel the Acceptance Order in whole or in part thereof due to any delay on the part of the Bidder to lift the entire material and may dispose of the un-lifted empty bottles/containers of the chemicals/fumigants through the other source at the **“Risk and Cost”** of the e-tenderer. The bidder shall also be liable for blacklisting in such a case.

Note: Any change in the constitution of the firms/ company/ society shall not absolve any partner/ Director/ Member of the firm/ Company/ Society from the liability unless it is agreed to by PUNGRAIN, in writing.

14. Termination for Default

A. PUNGRAIN may without prejudice to any other remedy or right or claim for breach of contract, by giving not less than 7 (Seven) days written notice of default to the Contractor, terminate the contract in whole or in part:-

- i.** If the Contractor breaches any of the terms and conditions of the contract.
- ii.** If the Contractor fails to comply with any or all the obligations under the contract within the time period(s) specified in the contract or any extension thereof granted by PUNGRAIN in writing.
- iii.** If the Contractor, in either of above circumstances, does not remedy its failure within a period of 7 (Seven) working days after receipt of the default notice from PUNGRAIN.
- iv.** If the Contractor in the judgment of PUNGRAIN has engaged in corrupt or fraudulent practices in completing or in executing the contract.
- v.** If the Contractor is blacklisted by the GST authorities.

B. If the information given by the Tenderer in the Tender document is found to be false/ incorrect and/or the documents uploaded are found to be forged/ fabricated at any stage, PUNGRAIN shall have the right to disqualify/summarily terminate the Contract, without prejudice to any other rights that PUNGRAIN may have under the Contract and Law. Also, the tenderer shall be liable for blacklisting and criminal proceedings can also be initiated against the tenderer.

15. Arbitration

- i.** All the disputes and difference arising out of or in any manner touching or concerning the agreement what so ever, shall be referred to the sole arbitration of arbitration of an Arbitrator to appointed by the PUNGRAIN from the panel of the independent arbitrators. The second party will have no objection to the appointment of the Arbitrator from the panel of independent Arbitrators maintained by PUNGRAIN, which is in consonance with the 7th schedule of the Arbitration & Conciliation Act, 1996. The award of the Arbitrator shall be final and binding on the parties to the contract. In the event of death of an Arbitrator his being transferred or vacating his office or being unable to act for any reasons, the Managing Director, PUNGRAIN at the time of such transfer, vacation of office, death or inability, shall appoint another person, to act as Arbitrator.
 - ii.** Subject to aforesaid, the Arbitration & Conciliation Act, 1996 (as amended in 2015) or any statutory re-enactment or modification thereof shall apply to the arbitration provided under this clause. The fee of the Arbitrator so appointed shall be governed by the terms and conditions of the PUNGRAIN.
 - iii.** All the disputes shall be subject to jurisdiction of courts at Chandigarh (UT) alone.
- 16.** Force majeure clause will be applicable.
